Meeting 8AM, March 16, 2010.

Motion to pay Post Office box for CBA for one year was approved. Motion was made by Donna **Riggle** and 2<sup>nd</sup> was by Carolyn Lawler.

We have paid our half of the electric bill for the Christmas tree, however, we still owe for half of the bill for the electricity for lights and repair of lights. Motion was made to pay our half of the bills by Aleta Richmond and 2<sup>nd</sup> by Donna Riggle. Motion approved.

Our meeting will resume at the Huddle House once the facility is open for business. The date and time of each meeting will be posted at the Claysville web site ([www.claysvillepa.com](http://www.claysvillepa.com)). The meeting minutes will also be posted for viewing at that site.

There was a meeting of the Redevelopment Authority concerning the Donegal/Claysville Multi-municipality Comprehensive Plan. The meeting was held at the American Legion on Tuesday, March 11, 2010. A discussion about the plan and procedures for future meetings. There is a need for a Chairman and Vice Chairman for the **Implementation Committee**. Participation in the plan is necessary for communities to be eligible for funding for community projects. Public forums will be held as the process progresses. Funding for the plan came through the **Local Share Account** and multiple accounts within the community and the Redevelopment Authority. The next meeting will be held at the West Alexander Municipal Building, April 6, 2010, 7: P.M.

CAPRI meeting was held March 8. They voted to go forward with the Community Center Project. They also held a Long Term Planning Meeting to determine future projects for the community. It was determined that committees would be formed for fact finding. It was also determined that CAPRI should recruit a representative from the school district. Next meeting will be the 2<sup>nd</sup> Monday of April at 6 P.M.

Carolyn Lawler announced that there would be a fund raiser for the Community Center Project on March 20<sup>th</sup>, at the American Legion. This will be a buffet style dinner sponsored by the Community Center Committee. Volunteers are needed to serve.

The Pike Days festival is in the planning phase. Pike days will be May 15 and 16. There will be a 5K run, vendors and live music. Plans continue.

Donna Riggle reported from the Buffalo Creek Watershed Association – They receive no funding **from the Local Share Account** for the Dutch Fork Lake restoration **project**. The engineering study has been completed. They will be ready for bids to be requested sometime in February. There is still a need for somewhere between \$1.5 and 2.2 Million in funding. An account has been setup for the Washington County Watershed Alliance. If you make a donation, the check should be made to the Alliance with annotation of Dutch Fork Lake Restoration. The original funds must be spent by 2012. No further information is available on the Range Resources contributions due **to** lack of **an** agreement on use of the

water. A suggestion was made that a request for funding from the gas/coal company should be pursued by the non-profits involved. This may fall under the Fish and Game commission authority.

It was noted that one of the Town homes was under contract.

There was a request that the mayor talk to the borough about replacing missing Claysville banners that have been damaged by weather.

Claysville Community will be sponsoring a Relay for Life event on June 12 and 13. This is a fund raising event in support of the Cancer Society and Caregivers program. The event will be held at the McGuffey High School Track. More information will be forth coming. Contact is Dennis Dutton (?).

An announcement was made the Randy Shook has invited everyone to a special presentation event at the Claysville Fire Hall on Thursday, April 1, 6 PM.

A question was asked about whether or not donations could be taken to replace plants in the planters along main street. Donations of \$ and plants can be taken. Planters should be planted soon.
